- The Islamic Republic of Pakistan has received a loan from the Asian Development Bank (ADB) towards the cost of **FATA Water Resources Development Project (FWRDP)** (the Project). Part of this financing will be used for payments under the contract named hereunder. Bidding is open to all Bidders, who can prove their eligibility and qualification as mentioned hereunder and in the Bidding Documents, from eligible source countries of the ADB.
- The Project Management Unit, FATA Water Resources Development Project, Sustainable Development Unit, P&D Department Khyber Pakhtunkhwa, Peshawar ("the Employer") invites sealed bids from eligible bidders for the *above mentioned sub-projects at Mohmand and Khyber Districts under FWRDP* ("the Works").
- National Competitive Bidding (NCB)** will be conducted in accordance with ADB's **Single Stage: Two Envelope bidding procedure** and is open to all Bidders from eligible countries as described in the Bidding Documents.
- Only eligible National Bidders, registered with **Pakistan Engineering Council** and having a valid registration Certificate in **Category C-3** or above with Specialization in **CE-01** and **CE-04** can participate in the bidding.

Technical Bids will be opened at **1430 hours** on **17 September, 2020** in the presence of bidders' representatives who choose to attend, whereas the Financial Bids shall remain sealed and unopened and shall be placed locked. The Financial Bids of only Technically Responsive and Qualified Bidders shall be opened after technical bids evaluation, whereas, the financial bids of those bidders whose technical bids are not responsive and unqualified shall be returned unopened.
